**Item 3.02 - Unregistered Sale of Equity Securities.**

In connection with the continuous private offering (the “Private Offering”) of New Mountain Private Credit Fund, a Maryland statutory trust (the “Company”), as of February 3, 2025, the Company sold an aggregate of 22,346 of its common shares of beneficial interest, par value \$0.01 per share (the “Shares”), for aggregate consideration of approximately \$0.6 million at a price per Share equal to \$25.06. The offer and sale of the Shares was exempt from the registration provisions of the Securities Act of 1933, as amended, pursuant to Section 4(a)(2) and Rule 506 of Regulation D promulgated thereunder.

**Item 7.01 - Regulation FD Disclosure.*****February 2025 Distribution***

On February 26, 2025, the Board of Trustees of the Company declared a regular distribution in the amount of \$0.19 per Share, payable to shareholders of record as of the open of business on February 28, 2025 and will be paid on or about March 28, 2025.

This distribution will be paid in cash or reinvested in Shares for shareholders participating in the Company’s distribution reinvestment plan.

**Item 8.01 - Other Events.*****Net Asset Value***

The net asset value (“NAV”) per Share as of January 31, 2025, as determined in accordance with the Company’s valuation policy, is \$25.06.

As of January 31, 2025, the Company’s aggregate NAV was approximately \$978.1 million, the fair value of its investment portfolio was approximately \$1,580.3 million, and it had approximately \$595.2 million of debt outstanding (at principal). The average debt-to-equity leverage ratio during January 2025 was approximately 0.60 times. As of January 31, 2025, the Company had approximately \$850.0 million in committed debt capacity, with 66% in floating rate leverage, of which 100% is secured, and 34% in fixed rate leverage, of which 100% is unsecured, based on drawn amounts.

***Status of Offering***

The Company is currently offering Shares on a monthly basis as part of the Private Offering. The following table lists the Shares issued and total consideration for the Private Offering as of the date of this filing. The table below does not include Shares issued through the Company’s distribution reinvestment plan. The Company intends to continue selling Shares in the Private Offering on a monthly basis.
